
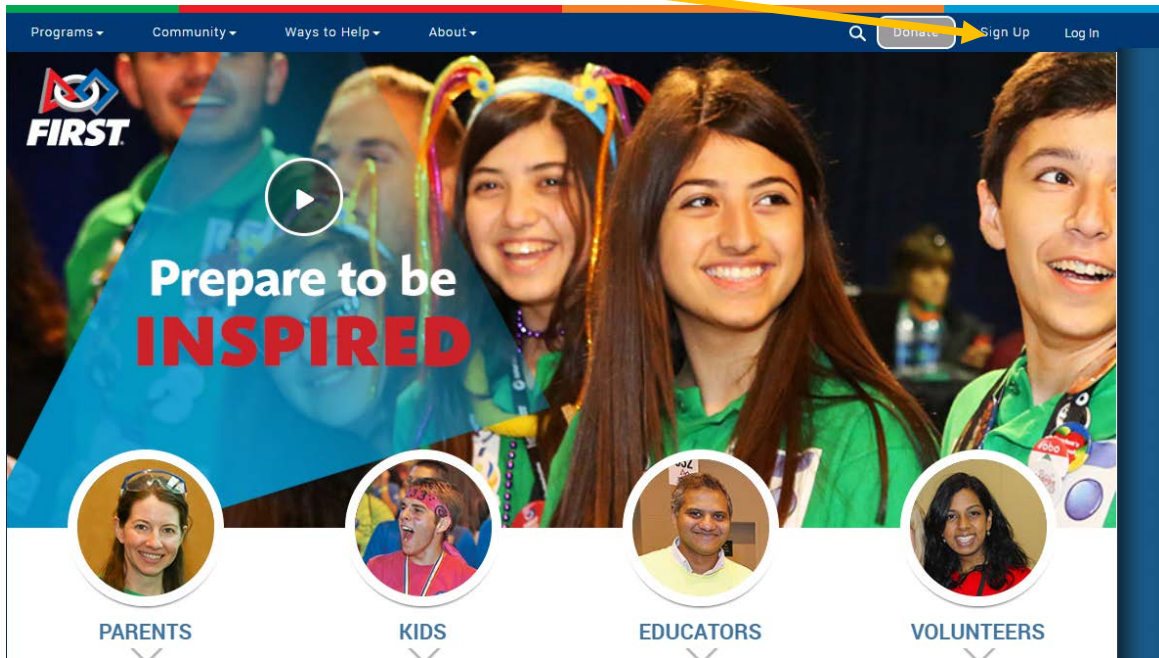




## How to Register a Youth for FRC

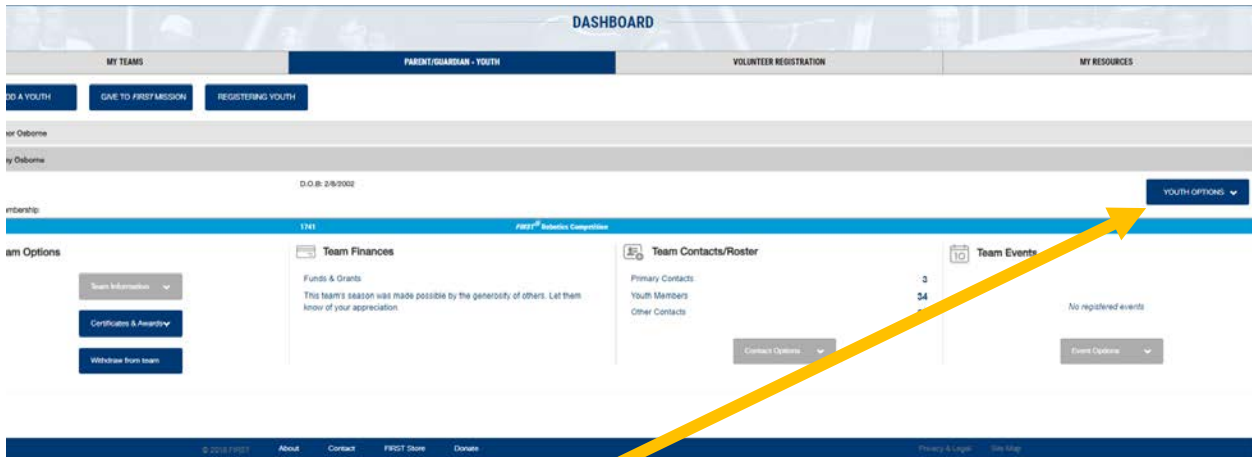

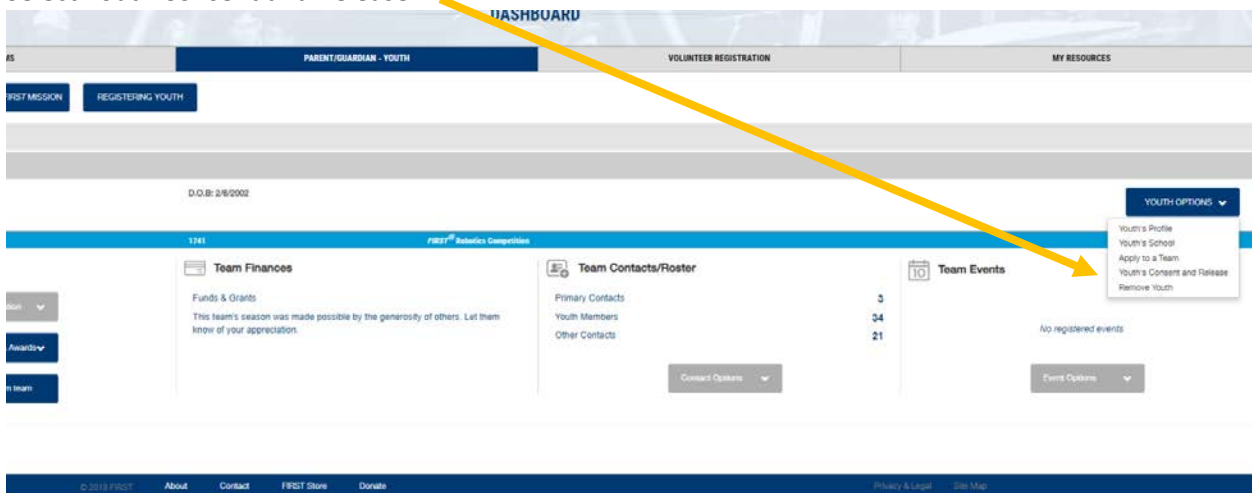

**Voluntary Participation:** I, as Participant (and Parent/Guardian of Participant if Participant under 18 years of age), understand and confirm that participation in the Indiana FIRST Event is wholly voluntary. "Participant" means any person participating, attending, coaching, judging, volunteering, mentoring, and/or involved, in any capacity, in any Indiana FIRST Event.

**Assumption of Risk:** I, as Participant (and Parent/Guardian of Participant if Participant under 18 years of age), understand and acknowledge that there are risks associated with participation in Indiana FIRST Events, including the potential for serious bodily injury, death, or the loss of or damage to property. I, as Participant (and Parent/Guardian of Participant if Participant under 18 years of age), HEREBY ASSUME ALL RISKS THAT ARE RELATED TO PARTICIPATION in the Indiana FIRST Event, whether known or unknown, foreseeable or unforeseeable, or patent or latent. I understand that these risks may be caused in whole or in part by the Participant's own actions or inactions, the actions or inactions of other participants, or the negligence of Indiana FIRST, or its respective directors, officers, officials, employees, agents, volunteers, activity coordinators, successors, assigns, or related parties. I, as Participant (and Parent/Guardian of Participant if Participant under 18 years of age), HEREBY ASSUME FULL RESPONSIBILITY FOR SUCH RISKS AND FOR ANY LIABILITY, INJURY, LOSS, OR DAMAGE related to participation in the Indiana FIRST Event.

**Indemnity:** I, as Participant (and Parent/Guardian of Participant if Participant under 18 years of age), HEREBY AGREE TO INDEMNIFY, DEFEND, AND HOLD HARMLESS INDIANA FIRST, AND ITS RESPECTIVE DIRECTORS, OFFICERS, OFFICIALS, EMPLOYEES, AGENTS, VOLUNTEERS, ACTIVITY COORDINATORS, SUCCESSORS, ASSIGNS, AND RELATED PARTIES from any and all third-party claims, losses, or demands of any kind which may relate to Participant's participation in the Indiana FIRST Event, including claims, losses, or demands caused in whole or in part by the negligence of Indiana FIRST or its respective directors, officers, officials, employees, agents, volunteers, activity coordinators, successors, assigns, or related parties. **Authorization to Reproduce Physical Likeness:** I acknowledge that Indiana FIRST Events are semi-public events that may be attended by the members of the press, business corporations, and media ("Commercial Guests") not under the control of Indiana FIRST who might photograph or videotape the event. As a matter of practice, Indiana FIRST asks Commercial Guests to comply with the Indiana FIRST policy of not printing a Participant's name with his/her picture, and Indiana FIRST asks them not to use images of Participants for commercial purposes without obtaining specific written permission from the Participant (or Parent/Guardian of Participant under 18 years of age).

**Consent to Medical Treatment:** I authorize Indiana FIRST or its respective directors, officers, officials, employees, agents, volunteers, activity coordinators, successors, assigns, or related parties to provide Participant customary medical assistance, transportation, and emergency medical services. This consent does not impose any duty or obligation on Indiana FIRST or its respective directors, officers, officials, employees, agents, volunteers, activity coordinators, successors, assigns, or related parties to provide any such assistance, transportation, or service.

**Severability:** Each term and provision of this Agreement shall be valid and enforced separately to the fullest extent permitted by law.

**Applicable Law:** This Agreement shall be governed, construed, and enforced in accordance with Indiana law, and any lawsuit must be brought in Marion County, Indiana.

**Safety Rules:** I acknowledge and understand that Participants are required to abide by all safety rules and instructions at the Indiana FIRST Event. I, as Participant (and Parent/Guardian of Participant if Participant under 18 years of age), agree that Participant will abide by all safety rules and instructions or will be subject to removal from the Indiana FIRST Event at Indiana FIRST's discretion, without any refund for the Indiana FIRST Event.

**Disclaimer:** Any Participant under 18 years of age must have a Parent/Guardian sign this Agreement.
